## Things to Remember When Doing Online Entries



The October Members Comp was our first show using electronic entries via [showmanager.com.au](http://showmanager.com.au). Over half of the entries were processed on-line. We have received feedback regarding how to request Grading Certificates when entering on-line. After discussion with the system developers, a message has been placed in the system with an email address for exhibitors to advise if they require certificates. Once you have notified your requirements there is no need to do this each time as a record will be kept with your request.

On-line entries has highlighted a problem which has occurred with paper entries for many years regarding when the “**initial entry fee**” versus the “**subsequent entry fee**” should be paid. The following example may help to explain when an initial entry must be paid.

*If **Joe Blow** owns a dog solely and is also in partnership owning another dog with **Fred Nerk** and Joe submits both entries, **each entry attracts an Initial Entry fee** as each dog has a different **OWNER** or **GROUP OF OWNERS**. It doesn't matter that the dogs live with Joe the ownership is different and two Initial Entries must be received.*

The system developers will be making a change to ensure that correct payment is received, however as the Open Show is already in the system and entries are being received, some of you may be required to pay the additional amount at Vest Collection. The problem will be rectified for our first show in 2016.

When consolidating the electronic and paper entries to produce the catalogue, it has become evident that exhibitors need to take more care when entering information about their **OWN** dogs. How you enter this data is how it will be printed! In this catalogue some “obvious” corrections to the on line entries have been made but this may not be the case in the future.

Please note the following:

- Where the Initial Entry was not charged or paid for this show **each owner** and/or **group of owners/partnership** will be required to pay any additional amount due and payable prior to the collection of vests. This has been past practice with paper entries and will continue.
- Check the spelling of your kennel prefix, dog and exhibitor names. Existing dog records in the Show-manager program can be edited if required.
- If your dog has a title please include this in the name field e.g. Ch or ET or CDX etc. If your dog has an A and Z stamp, please include the “AZ” at the end of the name.
- If your dog has been successfully breed surveyed please include an \* BEFORE the name. Do not include “BSC1” or “Breed Survey Class I” or “BS1” after the name.
- Sire and Dam information to include the \* for breed survey status, titles and AZ where applicable.
- Do not include the \* denoting successful survey status if an animal has **NOT BEEN** successfully surveyed. This includes information for Sires and Dams.
- At shows that are run under the Dogs SA rules, (November Open Show, June Championship Shows and Nationals) each entry on line will be printed by the show manager as per canine control requirements. If owner/exhibitors details are incorrect at these shows, entries may be refused.

How you enter the data is very important as that is what is used for the catalogue, so please take a little time to review your dog's data to ensure that it is correct.

Thanks for your patience with the “teething problems” of going electronic. We're glad this was well received and hope that it continues to get support.

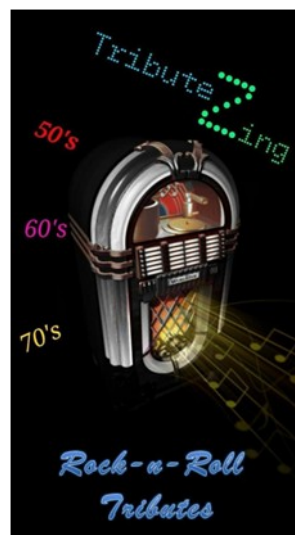

## **GROUND RULES**

**These rules apply to all handlers during training sessions and have been formulated for the welfare of you and your dog.**

**Any Club member, or any person guilty of unseemly conduct or acts harmful to the club, may be asked to leave the Training area. They may also be dealt with by the Committee of The GSDC of S A Inc. under clause 6, and relative by-laws of the Clubs Constitution.**

**Any dog which is sick WILL NOT be permitted onto the Club grounds.**

**Dogs who have suffered a CONTAGIOUS DISEASE WILL NOT be allowed on to the grounds until 5 weeks after being cleared by a veterinarian (a vets certificate may be required). Puppies should not be brought out onto the Club grounds under the age of 8 weeks or at least 2 weeks after they have been inoculated for HEPATITIS, DISTEMPER AND PARVOVIRUS (vaccination certificate may be required).**

**Bitches in season are not permitted on the grounds unless at a recognised Club event.**

**The use of switches, spiked collars or whips is STRICTLY FORBIDDEN ON THE CLUB GROUNDS.**

**Members shall not treat their dog in a manner which may reflect badly on the Club.**

**Dogs are NOT to be taken off-lead or left unattended, except on the directives, or under the supervision of a Class Instructor.**

**The handlers of dogs which foul the Club grounds, will be responsible for cleaning up same, with the equipment provided.**

**The Head Instructor has the authority to permit the use of a muzzle or training devices, as required in special cases. The use of the equipment is to be under supervision, and its use on the grounds, other than above, is STRICTLY FORBIDDEN.**

**Dogs under the age of 12 months ARE NOT permitted to use jump equipment higher than 400 mm, or longer than 800 mm.**

**Pursuant of the Health act "Dogs" ARE NOT permitted inside the Clubrooms.**

**In the interest of safety and health, and in consideration of others, parents are required to super-vise the behaviour of their children. The Clubrooms and Toilets MUST NOT be used as playing areas.**

**In the interests of public health the Clubrooms and the verandah area are NON-SMOKING areas.**

**TRAINING HEAT POLICY** If the forecast temperature is predicted to be 38 degrees or above on channel 9 weather at 6pm the night before training, (Wednesday nights or Sunday's), all training will be cancelled.

**Appropriate foot wear must be worn at ALL times when handling / double handling dogs on the Club grounds. Bare feet, thongs, slip on shoes, high heels, sandals or crocs are not suitable foot wear and members wearing any of the above will be asked to leave the training area.**
