



#### Meet The Breeder

This is the second of the series of articles interviewing the Breeders and Instructors of the club. This interview was with Judy O'Loughlin of Arkahla Kennels. We hope you enjoyed the last article and continue to enjoy.

# I. When did you purchase your first German Shepherd Dog?

Wayne and I purchased our first GSD in 1982 from Roger & Judy Haysman. Wayne had always wanted a male GSD so "Monty" (Craisan Satans Destiny) was purchased as a pet/family companion. I trained him in obedience at Southern Districts and when he was about 8 months of age we took him back to visit Roger & Judy and they convinced us to try showing him. We were hooked, and the long learning curve started.

We were lucky as our first GSD was a very good representative of the breed. He had great success in the show ring being placed 6th, 8th & 4th Open Dog at National Shows, achieved his Australian Champion title and winning the Hero v Grundel Trophy in 1986 for Challenge Dog at the SA Championship Show. He also gained his ET title and 2 legs of his CD but that 3rd leg eluded us as we lost Monty to bloat when he was just 6 years of age.

# 2. How did you come up with your kennel name, "Arkahla", what does it mean?

The name Arkahla comes from the word "akela" a scouting term for "leader of the pack" and also the name of the wolf in the "Jungle Book". Superstitious me had to have 7 letters in the name so it got changed a bit.

# 3. In what year was Arkahla Kennels established?

Our kennel was established in 1994 by Judy & Wayne O'Loughlin and in later years our son, Andrew has become involved too.

# 4. What is your preference – specialty ring or all breed ring and why?

Personally I prefer the speciality ring. I think it means more to do well under a specialist GSD judge, especially when gradings are given.

#### 5. What is your most memorable moment during your breeding career?

As a breeder my most memorable and pleasing moments would be seeing puppies you have bred grow up to be good representatives of the breed, and when those pups have lived out their lives the owners coming back to you for their next dog.

Also we have bred animals that have excelled in the show ring for us and that is also pleasing.

# 6. How do you think the breed has changed since you started Arkahla Kennels?

I believe that the biggest improvement in the breed since we became involved has been in hips and elbows with the implementation of the HD & ED schemes. Size has become a problem since we became involved, as has overangulation of the hindquarter.

There will always be problems as

the perfect dog is yet to be bred!!

# 7. Do you have a favourite Arkahla dog?

I have 2 "heart" dogs, both of whom we lost too early.

The first is Monty (\*Ch Craisan Satans Destiny A); the dog that introduced me to showing/breeding and the second is Tilda (\*Ch Arkahla Waltzing Matilda AZ) who showed so much promise as a show dog until we lost her at just over 4 years of age to a relatively unknown fungal disease in her spinal chord.

# 8. What advice would you give to those starting off a breeding kennel?

Friends of ours have always told us that to be a successful breeder you need a strong and predictable bitch line. We have found this is not an easy thing to achieve. You can purchase a bitch but you then have to consolidate what you are hoping to achieve in your kennel. Usually this is not something that will happen quickly and there are bound to be disappointments along the way. The joys of breeding.

# 9. What is your vision for the future?

My vision for Arkahla kennels has to some extent already been fulfilled. That is for Andrew to continue our promotion and commitment to the breed we love. Page 8 Shepherd News





#### **GROUND RULES**

These rules apply to all handlers during training sessions and have been formulated for the welfare of you and your dog.

Any Club member, or any person guilty of unseemly conduct or acts harmful to the club, may be asked to leave the Training area. They may also be dealt with by the Committee of The GSDC of S A Inc. under clause 6, and relative by-laws of the Clubs Constitution.

Any dog which is sick WILL NOT be permitted onto the Club grounds.

Dogs who have suffered a CONTAGIOUS DISEASE WILL NOT be allowed on to the grounds until 5 weeks after being cleared by a veterinarian (a vets certificate may be required). Puppies should not be brought out onto the Club grounds under the age of 8 weeks or at least 2 weeks after they have been inoculated for HEPATITIS, DISTEMPER AND PARVOVIRUS (vaccination certificate may be required).

Bitches in season are not permitted on the grounds unless at a recognised Club event.

The use of switches, spiked collars or whips is STRICTLY FORBIDDEN ON THE CLUB GROUNDS.

Members shall not treat their dog in a manner which may reflect badly on the Club.

Dogs are NOT to be taken off-lead or left unattended, except on the directives, or under the supervision of a Class Instructor.

The handlers of dogs which foul the Club grounds, will be responsible for cleaning up same, with the equipment provided.

The Head Instructor has the authority to permit the use of a muzzle or training devices, as required in special cases. The use of the equipment is to be under supervision, and its use on the grounds, other than above, is STRICTLY FORBIDDEN.

Dogs under the age of 12 months ARE NOT permitted to use jump equipment higher than 400 mm, or longer than 800 mm.

Pursuant of the Health act "Dogs" ARE NOT permitted inside the Clubrooms.

In the interest of safety and health, and in consideration of others, parents are required to super-vise the behaviour of their children. The Clubrooms and Toilets MUST NOT be used as playing areas.

In the interests of public health the Clubrooms and the verandah area are NON-SMOKING areas.

#### **Training Extreme Weather Policy**

Training will be cancelled if the forecast temperature for <u>West Beach</u> is predicted to be 37 degrees or above or an Extreme Storm warning is issued on <u>www.eldersweather.com.au</u> at 6pm the night before training (Wednesday nights and Sunday mornings).

Appropriate foot wear must be worn at ALL times when handling / double handling dogs on the Club grounds. Bare feet, thongs, slip on shoes, high heels, sandals or crocs and shoes with metal-spiked soles are not suitable foot wear and members wearing any of the above will be asked to leave the training area.
