Highlights from the Judges and NBC Meeting

Motion: "That a formal approach be made to the ANKC that would see the following apply at GSDCA National shows as of 2021".

Clubs are asked to vote on each requirement, noting if supported a case will be put to ANKC in order to gain approval in time for 2021 GSDCA National Show.

1. That only animal's that are GSDCA Breed Surveyed or equivalent as recognised by the GSDCA, will be eligible to enter the conformation Open Class (conformation).
 - a. The age limit will be set at 2 years and over.
2. That only animal's that have passed the GSDCA Control Scheme A (HD) and Z (ED) stamps or equivalent as recognised by the GSDCA will be eligible to enter the conformation Intermediate classes (Conformation).

Meet The Breeder

This is the third of the series of articles interviewing the Breeders and Instructors of the club. This interview was with Vivien Drummond of Damonte Kennels. We hope you enjoyed the previous articles and continue to enjoy.

When did you purchase your first German Shepherd Dog?

Obscure as it may sound, I purchased my first Purebred German Shepherd for \$50 at a garage sale in Whyalla nearly 20 years ago. It was a 13 month old female LSC (lol) who was tied to a clothes line. She was owned by an old Greek couple. Upon questioning them about her it was evident she had been living tied up since a puppy. 'Stupid dog' they called her. I said, I'll give you \$50 for her and they said, yes. I couldn't leave her there.

My first Pedigree GSD was purchased in 2005. "MONTE" (CH Rhosyn Monterey CDX). I purchased him from Stephen & Christine Collins of Rhosyn Kennels. I had been brought up as a child with the family dog being a GSD (SC) lol. I just love the look, character and strength of the breed.

What was your first Discipline?

My first discipline was obedience. Mum and Dad had an obedience club in Whyalla named, DWDOC. (Dakalanta Working Dog Obedience Club).

How did you come up with your kennel name "DAMONTE"? What does it mean?

The first two letters DA are from CH Darkana Charity CD, (ZOEY) a Leberhine Ijaz Daughter. The remaining letters spell MONTE (CH Rhosyn Monterey CDX) which was my heart dog and founder of the Kennel. Zoey was his first wife.

In what year was Damonte Kennels Established?

Damonte Kennels was established in 2006.

What is your preference-Specialty ring or all breeds ring and why?

I enjoy both for different reasons. My preference though is for the Specialty ring. As a Breeder, I believe that generally the opinions Specialty Judges give you are an indication of where you are or where you need to be with the breed standard rather than a General all Breeds Judge. Also I believe having your dogs graded by a specialist is very important for your breeding program and personal achievement.

What is your most memorable moment during your breeding career?

It's always nice to get comments / feedback from puppy buyers saying that they love the temperament of our dogs. I enjoy all the pictures and being included in their lives.

Michael and I are proud to have bred the 1st National Male (LSC) to gain Grand Champion. GR Ch *Damonte Bear Essentials AZ. 'Bear' also made us proud by taking 1st place in his class at two consecutive National events. Junior and Intermediate dog.

An exceptional memorable moment was, CH *ANDACHT THUNDA BOLT N LIGHTNIN AZ, (Rylee), placing 5th 2 years in a row at the 2018 and 2019 National.

How do you think the breed has changed since you started Damonte Kennels?

We couldn't participate in Specialty with our LSC'S till 2012 so this is a fantastic move forward for us and others. The numbers of competitive animals have increased since the variety was recognized. Stock Coat Breeders and Kennels are participat-

ing with LSC'S as well.

There are evident issues with height, ear firmness within the LSC and caution needs to be taken when pairing as you would with any breed. Pigment of coat is richer in colour and the sable variety is becoming more popular. So generally I feel the strength of the LSC has improved.

Do you have a favourite Damonte Dog?

I love them all but I do have a Heart Dog, 'MONTE' (CH Rhosyn Monterey CDX). He was the founder of my kennel, a true character and very clever dog. He excelled through obedience gaining his CDX title by 21 months of age. Monte also recieved the Joe Seidl Memorial Trophy twice for highest scoring Pedigree GSD in Trial. He was also a caring canine for the elderly. Sadly he is no longer by my side but will remain in my heart forever.

What advice would you give to those starting off a breeding kennel?

I would advise them to obtain strong bitch lines using Stock Coat lines as the best LSC'S are still proven to be bred from the Stock Coat. Speak to other breeders who have experience with all aspects of breeding / conformation.

What is your vision for the future?

Our vision is to continue striving to improve our bloodlines within our kennel. To breed sound and well structured dogs for show /pets. We are happy to be the small fish in the big pond and enjoy our dogs, be competitive and enjoy other like-minded people along the journey of Breeding.



Endurance Test

The German Shepherd Dog Club hosted our annual Endurance Test (ET) on Saturday 7 July 2019. For those who may not know, the ET is a test run over a 20km run and completed in 2 hours and 35 minutes. *The ET shall demonstrate the dog's ability to work after being subject to a certain degree of physical strain without showing signs of undue stress or lack of constitution. Due to the dog's physical structure, such a test can only consist of a dog travelling at a suitable pace for a performance of some lengthy duration, which, it is known places an increasing load not only on its internal organs, such as the heart and lungs, but on many other aspects of the dog's physical structure and temperamental characteristics. The effortless accomplishment of such a test shall be the evidence as to the physical fitness of the dog. (ANKC rules)*

The ET commenced at 8.00am and the weather conditions were perfect with a top temperature of around 17 degrees.

We had a total of 12 entries received. We had one scratching so had a total of 11 exhibitors on the day. The breeds represented were Belgian Shepherd, Standard Poodle, Australian Shepherd, Border Collie, Border Terrier, Samoyed and a Kelpie x Koolie. Two of the handlers jogged the course while the rest cycled.

The ET was judged by Mr Brian Fielder who cycled the course with the competitors. The veterinary surgeon was, Dr Neil Thies (BVSc (Hons) MAVS) from Willunga Vet Services who has been our 'resident' vet for the past 18 or so years. Dr Thies is a dedicated cyclist and swimmer and has completed several National Triathlon races and participated in the 20km+ Rottnest Island swim, off the coast of WA. Dr Thies has always jogged the 20km long ET and did so again this year! Our Pace Setter was, Wayne O'Loughlin who cycled the course leading the competitors and ensuring a consistent speed and time were kept. Our two time keepers were Andrew O'Loughlin and Gillian Smith who ensured that each section of the test and rest breaks were timed. Our assistants on the day were, Trial Secretary, Judy O'Loughlin, Club President, John De Lucia and Trial Manager, Jenny De Lucia.

Unfortunately, four dogs were deemed to be not able to complete the test and were withdrawn. The remaining seven competitors passed.

It was a very successful event enjoyed by all. Thank you to all involved.

Daniele is a conformation and obedience Judge from America who was in Australia with her husband, Pete visiting friends and decided that she wanted to watch an obedience event so ended up coming to our club. Both Pete and Daniele were amazed over the trials and very much enjoyed their stay. In true Shepherd Club style, Pete and Daniele and their two Australian friends were invited inside to have Kerry's knock out lunch and were extremely impressed with the quality of Kerry's food, so much so that both couples donated \$60.00 to the club as a 'thank you'. Our club President, John and Secretary, Stephen presented Daniele with a National Council Quarterly Review and a copy of The Condensed History of The German Shepherd Dog in Australia. Daniele was truly amazed and very appreciative and stated she would look forward to reading both on her long trip back home.

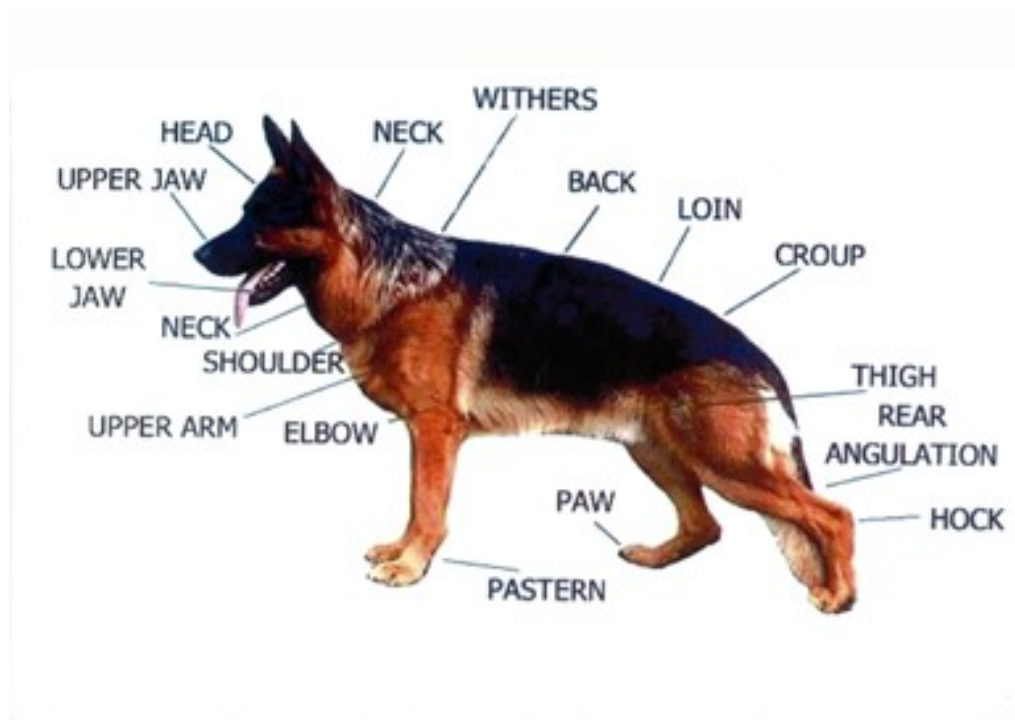

Rally-O Trial

The German Shepherd Dog Club Inaugural Rally O Trial was held on Sunday 4th August 2019 in the form of a Double trial with AM and PM.

For those who may be unfamiliar with a Rally Trial and what it is, here is an excerpt from the ANKC rules:

"The purpose of Rally Obedience is to demonstrate a dog's usefulness as a companion of mankind, not merely the dog's ability to follow specified routines in the ring. Dogs who participate in Rally are dogs that have been trained and conditioned to compete at Novice level and in the presence of other dogs. The objective of Rally is to provide a fast-moving and motivational sport for both Handler and dog that demonstrates competency in basic Obedience exercises without the precision of the formal Obedience Classes. Dogs in Rally events should demonstrate willingness and enjoyment.."

The Rally course consists of a series of 'stations' which show the handler what exercise to perform with their dog without the Judge telling them, so basically, the handler and dog compete the course themselves with the Judge watching and then scoring.

We had a modest entry of 35 competitors but the trials ran smoothly and although the weather was cold, thankfully, it did not rain.

Our judges were our own Mrs Jan Brabham and Mr. Neil MacDonald. Our stewards were, Bon Jordan and Helen Tamassy and two of our club members, Sandra Pilgrim and Andrew O'Loughlin.

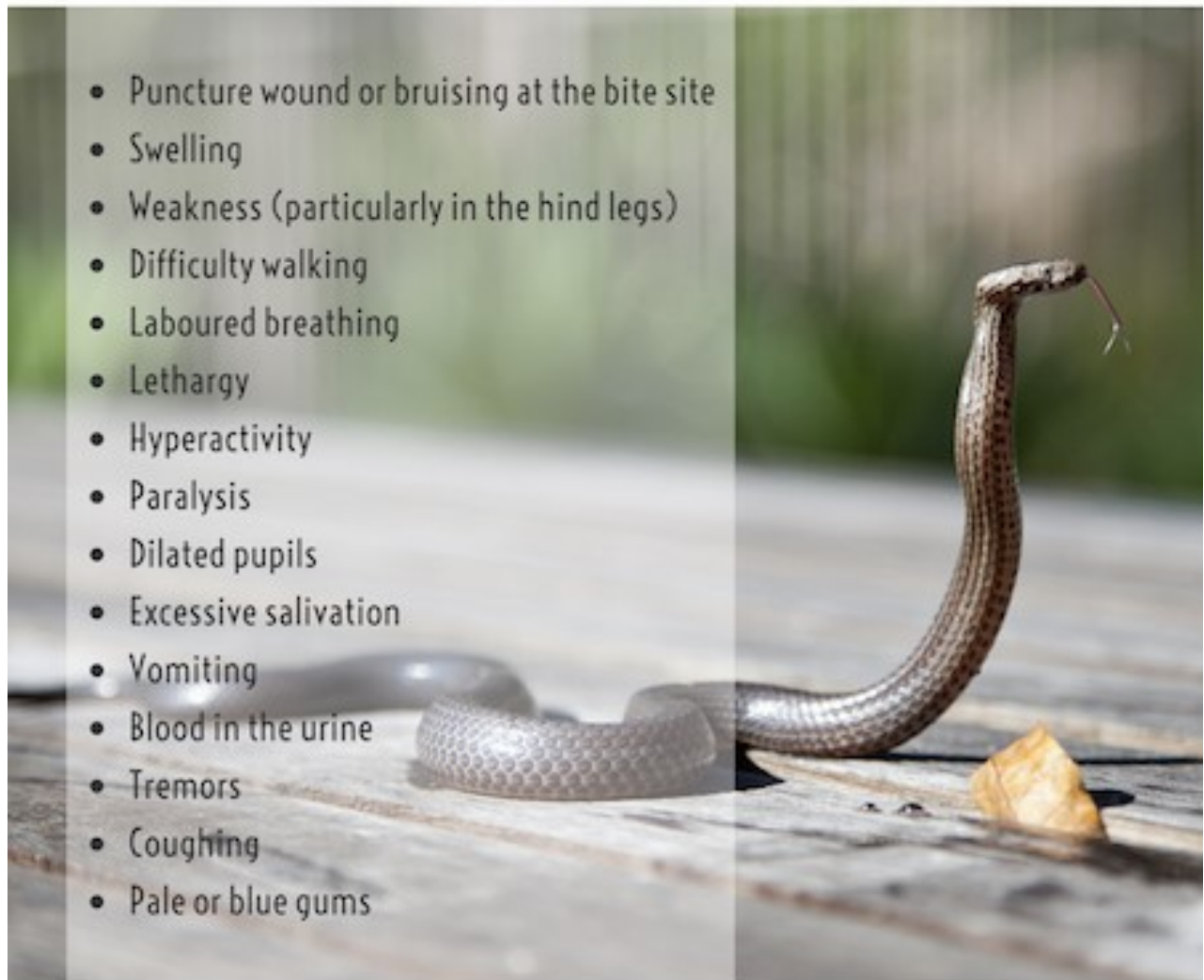

GROUND RULES

These rules apply to all handlers during training sessions and have been formulated for the welfare of you and your dog.

Any Club member, or any person guilty of unseemly conduct or acts harmful to the club, may be asked to leave the Training area. They may also be dealt with by the Committee of The GSDC of S A Inc. under clause 6, and relative by-laws of the Clubs Constitution.

Any dog which is sick WILL NOT be permitted onto the Club grounds.

Dogs who have suffered a CONTAGIOUS DISEASE WILL NOT be allowed on to the grounds until 5 weeks after being cleared by a veterinarian (a vets certificate may be required). Puppies should not be brought out onto the Club grounds under the age of 8 weeks or at least 2 weeks after they have been inoculated for HEPATITIS, DISTEMPER AND PARVOVIRUS (vaccination certificate may be required).

Bitches in season are not permitted on the grounds unless at a recognised Club event.

The use of switches, spiked collars or whips is STRICTLY FORBIDDEN ON THE CLUB GROUNDS.

Members shall not treat their dog in a manner which may reflect badly on the Club.

Dogs are NOT to be taken off-lead or left unattended, except on the directives, or under the supervision of a Class Instructor.

The handlers of dogs which foul the Club grounds, will be responsible for cleaning up same, with the equipment provided.

The Head Instructor has the authority to permit the use of a muzzle or training devices, as required in special cases. The use of the equipment is to be under supervision, and its use on the grounds, other than above, is STRICTLY FORBIDDEN.

Dogs under the age of 12 months ARE NOT permitted to use jump equipment higher than 400 mm, or longer than 800 mm.

Pursuant of the Health act "Dogs" ARE NOT permitted inside the Clubrooms.

In the interest of safety and health, and in consideration of others, parents are required to super-vise the behaviour of their children. The Clubrooms and Toilets MUST NOT be used as playing areas.

In the interests of public health the Clubrooms and the verandah area are NON-SMOKING areas.

Training Extreme Weather Policy

Training will be cancelled if the forecast temperature for West Beach is predicted to be 37 degrees or above or an Extreme Storm warning is issued on www.eldersweather.com.au at 6pm the night before training (Wednesday nights and Sunday mornings).

Appropriate foot wear must be worn at ALL times when handling / double handling dogs on the Club grounds. Bare feet, thongs, slip on shoes, high heels, sandals or crocs and shoes with metal-spiked soles are not suitable foot wear and members wearing any of the above will be asked to leave the training area.
